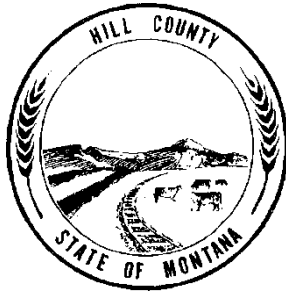

Dear Governor Gianforte and Ms. Slusser:

I am writing in support of Lacey Lincoln's application to serve as District Court Judge for the 20th Judicial District. I have worked in the Hill County Attorney's Office for the past ten years, and Lacey has been my boss since her 2021 appointment and later election to the position of Hill County Attorney.

My forty-year background in the legal field, as well as my first-hand knowledge of Lacey's work ethic, integrity, efficiency, and legal knowledge, allow me to make this unqualified recommendation for her appointment as the next District Court Judge for Lake and Sanders Counties.

Lacey grew up in a small town and practiced law in a small town in Washington before moving to Missoula and then Havre with her husband, whose family homesteaded north of Rudyard, Montana. Small town values are ingrained in Lacey with the added rare ability to understand and use "fancy big city" technology. In fact, her technological expertise has played an important part in the improvements Lacey has made in the Hill County Attorney's Office -- so much so that she has streamlined the operation of the office to function at maximum efficiency with minimal available resources.

Lacey is one the most well-organized, well-prepared, and hard-working attorneys I have worked with. When Lacey was first appointed as the Hill County Attorney, the office had experienced several turnovers resulting in a backlog of more than 300 criminal cases. Despite being the sole attorney in the office (where historically there had been one county attorney and two deputy county attorneys), Lacey has whittled that 300-case backlog to less than 30 criminal cases while keeping abreast of the current caseload. Lacey achieved this significant reduction in the criminal case backlog while handling District Court, Justice Court, Treatment Court, and spearheading the Hill County Children's Advocacy Center, in addition to providing civil assistance to the Hill County Commissioners, elected officials, and county employees.

One of Lacey's most important contributions to Havre and Hill County while serving as the Hill County Attorney is the re-establishment of the Hill County Children's Advocacy Center. Havre was lacking a "CAC" to provide services and referrals for medical and mental health treatment to child victims of abuse

and their families. Lacey spearheaded the CAC by obtaining donated office space and furnishings and setting up a safe and child-friendly space in which to conduct forensic interviews. She organized CAC volunteers from law enforcement and the medical community into a multidisciplinary team to coordinate services for the reduction of trauma to victims and increase the likelihood of successful prosecution of offenders. She also played a significant role in obtaining grant funding for operation of the CAC.

Lacey was instrumental in coordinating Hill County's part in the establishment of the Bullhook Butte hiking trail on the outskirts of Havre. She oversaw the legal intricacies involved in the County's role in providing public access easements, working in conjunction with private landowners and non-profit organizations to achieve a successful outcome for all parties involved.

In addition to her impressive ability to organize and run an office while handling a large caseload, Lacey has significant trial experience. Her ability to navigate complex legal issues in both criminal and civil matters make her particularly well-suited to serve on the bench. Lacey also has experience in working with the tribes of the Rocky Boys and Fort Belknap reservations.

Lacey's sense of justice and fairness, applied with impartiality and thoughtfulness, are attributes only the best judges possess. Her commitment to upholding the law is unparalleled. Her resolve to leave the place she is a better place when she leaves has been amply demonstrated during her tenure in Havre.

Thank you for considering Lacey Lincoln's candidacy for District Court Judge. I believe she will be an asset to the Montana judiciary and will serve the people of Lake and Sanders Counties well.
