

#### Dear Governor Gianforte:

I am writing in support of Seth Cunningham's application for appointment to serve as a district court judge in the Montana Thirteenth Judicial District. I am an attorney who practices primarily in Yellowstone County so this matter is of significant importance to me.

I have known Seth for several decades, both of us graduating from Billings West High School in 1996. Because of Seth's service in the United States Air Force, I completed law school at the University of Montana School of Law several years prior to Seth and believe that I am modestly responsible for his decision to attend law school and his recent willingness to switch from the bar to the bench.

Having practiced law since 2003, I have a personal sense of what makes a good judge. Recently, I served on the Senate Select Committee on Judicial Oversight and Reform which also gives me some insight regarding the qualities that Montanans respect in a judge.
