With respect to my background, I have been an active member of the State Bar of Montana since 1989. From 1989 to 2002, I worked as a prosecutor in the Montana Attorney General's Office, trying cases in most of the state district courts over the years. From 2002 to 2022, I served as an assistant United States Attorney (AUSA) for the District of Montana, trying many cases in Montana's federal courts. I was the chief of the United States Attorney's Office's Criminal Division from 2014 until my retirement in August 2022. Given this background, I believe I have a strong sense of the qualities that make for a great trial judge.

Colin served as an AUSA in Montana throughout my entire tenure as criminal chief between 2014 and 2022, so I became very familiar with him as a person and an attorney. As a person, Colin has all the qualities we expect of attorneys. He is highly intelligent, extremely ethical, committed to public service, and dedicated to the impartial application of the law in all cases. He has an excellent, very efficient work ethic. Colin is simply an outstanding person.
