My name is John Ryan. For the past five-and-a-half years, I served as a prosecutor for the Yellowstone County Attorney's Office. Prior to that service I clerked for one year for the Hon. Donald L. Harris of the Montana 13th Judicial District Court. In my time as a Senior Deputy County Attorney, I prosecuted about 25 cases to trial, primarily sexual and violent crimes. I served in the County's Special Victims Unit, a volunteer designation that focuses on crimes that not everyone has the stomach for—crimes of sexual and physical violence against children. During that time, it was my honor to call Ed Zink a supervisor and mentor. Today, it is my privilege to tell you about this good man who has become a great friend. I enthusiastically support Ed Zink's application to become our next district court judge. Mr. Zink brings an unparalleled depth of trial experience—to my knowledge he is the most-prolific homicide prosecutor in Montana this century. But more impressive than that, Mr. Zink is a man of unquestionable character and integrity, and he brings a frontline understanding of the needs and challenges of Montana's busiest courthouse.

The 13th Judicial District is a unique challenge for aspiring judges. The caseload is massive, often complex, and the stakes are often high. The people of Yellowstone County need judges who can fairly, efficiently, and effectively move cases. A lawsuit or a criminal proceeding generally represents the worst-case scenario for all parties involved. Whether someone is the

victim of a crime, a criminal defendant, civil defendant, or plaintiff—that person deserves timely attention to their case. Beyond work ethic, and faithfulness to the law, a great judge must be fair, be thoughtful, and have appropriate temperament. The public does not often get to see this side of Mr. Zink, due to the nature of his job. But I have personally seen the care and comfort he's afforded grieving victims and families as he prepares and counsels them through reliving true horrors. I have seen Mr. Zink pull in prosecutors of all backgrounds and experience levels to mull their input on responses to complex legal issues. I have seen him lecture prosecutors and coach up law enforcement on the rare occasion where a mistake has been made, it has unfairly impacted the rights of an accused, and the offense must be remedied. Mr. Zink is a man who is compelled: 1) to do the right thing, and; 2) to do right by his neighbors.

To that end, Mr. Zink is thoroughly a product of Eastern Montana, and its values. This is in part why he has been so successful in front of so many Yellowstone County juries. He understands our community. He understands that this is still a place of plain-speaking folks who value character, courage, and conviction. If a person has the character to know what the right thing to do is, they have the courage to choose the right thing (even when the wrong thing is often more convenient), and they have the conviction to stand by their decision—what more could be said to that person's credit?

Surely, I can think of none. Which is why, putting it plainly, Ed Zink is the best pick to be our next district court judge. Thank you for your consideration.

perseverance it takes to work and succeed in the busiest county attorney's office in this State. These are the attributes that will make Ed a successful District Court Judge.


