It is my pleasure to write this personal letter of support for Gregory Bonilla for consideration as you review nominations for the Ninth Judicial District Court Judge. I have worked with Mr. Bonilla at the Montana Association of Counties (MACo) for the past 4.5 years. It is small part of his nearly 14 years at MACo which include 10 years as managing counsel. In his position he has been an integral part of leading the MACo defense team representing counties insured by our Property Casualty Trust. Cases of note during his time at MACo are *Renenger v. State and Jefferson County* and *Longsoldier (Stricker v. Blaine County and Hill County)*.

I am not an attorney, but here is my understanding of the cases and why they are a couple of important examples of the work Mr. Bonilla has been involved in.

In *Renenger*, Plaintiffs argued that the public duty doctrine (which is very important to local governments and the state) did not apply to law enforcement investigations. The public duty doctrine holds that where the government owes a duty to the whole public (like the duty to keep the peace), it does not owe any specific person a duty and, therefore, cannot be held liable for an alleged harm to one member of the public. If the public duty doctrine did not apply, law enforcement could get sued any time someone didn't like the results of a particular investigation or the prosecutor didn't obtain a conviction. That result would be timely and very, very costly. In *Renenger*, the public duty doctrine was preserved and the Supreme Court indicated that investigations were precisely the sorts of things the doctrine was meant to protect. That was a 2018 case.

Several aspects of the *Longsoldier* litigation have gone to the Supreme Court, but the issue Mr. Bonilla directly argued was the appropriate standard of review the Human Rights Commission (HRC) used in reviewing appeals of contested case hearings. The HRC were using the "clearly erroneous" standard as opposed to the far more restrictive "substantial evidence in the record" standard. The clearly erroneous standard made it a lot easier for the HRC to overturn a hearing examiner's trial verdict. The Supreme Court told them they can't use that standard anymore as a matter of law. That has resulted in a positive shift in the way the HRC does some of its business.

Again, it is my pleasure to submit these personal comments on behalf of Mr. Bonilla.
