Dear Selection Committee for the 18th Judicial District:

I am writing to encourage you to select Andy Bruener for the new district court position in Gallatin County. I have been working as an attorney for 13 years – 8 of these years as the County Attorney in Meagher County from 2010-2018 and most recently as a defense attorney. I took on a stack of public defender cases in the Bozeman/Belgrade area over the past year and I have had the chance to work closely with Judge Bruener in the Belgrade City Court. I feel like I have a good point of view from which to write this recommendation. He is truly a judge for the modern era. As practicing attorneys, we need judges to be accessible and understanding and work with people to resolve their matters, not against them, and Judge Bruener certainly accomplishes this.

First: Judge Bruener treats everyone in the courtroom: defendants, counsel and support staff alike, with respect, courtesy and fairness, even when it's been a grueling day. Belgrade is a busy municipal jurisdiction and we have encountered some exhausting clients, trials and matters. In my experience in his courtroom, Judge Bruener's patience literally never waivers. I, for one, have truly appreciated this because it's often been my clients who are the cause of some difficulties! However, Judge Bruener never takes anything out on attorneys, defendants or his staff. He is just extremely pleasant, despite difficult scenarios. As a case in point, I once had a client of mine barge into a full open court with her emotional support chihuahua (she was not on the calendar) demanding to be heard on something trivial. I was mortified. I thought I was finally going to see Judge Bruener's temper because I wanted to lose my temper. However, he was absolutely kind to her. He did not make one mention of her obnoxious animal and he stopped all proceedings and just found a time slot when she could next be heard and was even extremely nice about the entire disruption, as she obviously has a mental health issue, which he could see. He takes everything in stride and just moves on or possibly makes a joke about things, if the situation warrants it, which makes everyone else comfortable, and breaks the ice, in spite of the situation.

Second: Judge Bruener is flexible about the way that things are in the real world and he is isn't caught up in the formalities of the past, which can be helpful, especially when there is a lot to do. For example, he understands that people cannot always get child care to get to court. If people show up with children in tow, he immediately points out that he understands that this was probably not what they had planned on this day, but that it is absolutely fine – it's more important that they SHOWED UP. In Judge Bruener's courtroom, people do not have to be uncomfortable or leave the area just because they have a child with them or happen to be wearing their work clothing. Some judges in other jurisdictions are actually still inflexible about simple issues like this that people may have no control over. These antiquated attitudes hurt access to justice and Judge Bruener's attitude is extremely helpful and a huge relief to people. People with limited financial resources are not able to get to court if they are restricted from taking their child with them or do not have time to change our of their work clothing and they do not need to be belittled for it. Judge Bruener is very accommodating to people and I appreciate that and so do all of my clients and you might be surprised to know that it is <u>rare</u>.

Judge Bruener is understanding of real people and their issues and this should be praised because the court deals with real people with real problems, like poverty and mental health. The 18<sup>th</sup> Judicial District Court will not always, or even often, be dealing with the issues of the wealthy, and will certainly have to encounter people who do not have it all together, such as accommodating people who do not have child care on the day of court and accommodating work schedules, so they don't lose their jobs and become homeless. Judge Bruener has made the Belgrade Court completely user friendly to the people who need it and welcoming and it's extremely helpful. The job of judge is first and foremost

about public service. We have to move into a modern era that accommodates, not frustrates. Judge Bruener has definitely made that clear in Belgrade – he is a true public servant and that is the role of judge.

Third: He has gained the respect of nearly everyone that has come into his court. I have had several Belgrade clients decide to simply own up to their crime because they "didn't want to disappoint Judge Breuner" or "waste Judge Bruener's time" by taking something to trial that they know that they did. This was initially quite mind-boggling to me as their legal counsel, but quite a testament to the effect a judge can have on repeat offenders. He is incredibly well-respected in his community because he is fair and decent and he is actually a good person and it shows. The people who come before him have good reason to trust him. He never goes "off shift" on a defendant simply because he is having a bad day. I can't say this about the other courts. I can completely trust that my clients will get fairness when the time comes and we can trust that Judge Bruener won't pull a fast one on sentencing because he doesn't like them or is in a bad mood that day. This means a lot!

I'm taking the time to write this because Judge Bruener has had an effect on me as an attorney, as well. I came back to practicing law after taking some time off from the practice. After returning to work, I agreed to take cases in about 10 different jurisdictions. After getting a great deal of experience in these different courts, I will say that I like to practice in Judge Bruener's court the most. Because of this, I have recently tried to limit my cases to only his court because I do not enjoy practicing in some of the other judge's courts because, frankly, some of them are actually openly unpleasant or unkind to criminal defendants. Criminal defendants are largely suffering from poverty, mental health issues and lack of education. The system needs change, but until it changes we need to work together to reduce crime through other means. Judges who choose to berate and belittle these individuals need to be removed from their posts and kept far away from positions of power because they do so much more harm than good. Judge Bruener cares about people and wants to help them get their lives on track so that crimes are in the rear view mirror for them. Obviously, jail is sometimes a component of the sentence, but you can always hear in the sentence that he actually cares about people and the defendants can tell. Overall, this is the most important quality in a judge.

As a district court judge, I realize Judge Bruener will have other responsibilities outside of the criminal realm, however, the criminal docket will be significant, I imagine. Since that it my experience with Judge Bruener, that is all I can speak about. But, I can say that he is very intelligent and honest and has a sense of humor so I am quite sure he will handle all of the aspects of the position with high quality and integrity.

It is imperative that you choose people like Judge Bruener for these important positions because he has a proven track record of treating all people with fairness, tolerance, respect and compassion. Without a doubt, these are the traits that you should be seeking for your judicial posts and I sincerely hope that you choose Judge Bruener.

Thank you for taking the time to consider Andy Breuner for the Eighteenth Judicial District Judgeship, I am writing today to share a character reference on behalf of Andy. I have known Andy for over twenty-five years, he is my brother-in-law.

I am thankful to know Andy as my brother-in-law, but I have also been fortunate to work with Andy and see his approach to his work with the law and his respect for human dignity firsthand. Early in my own career, Andy gave me the opportunity to provide office support to the criminal defense clinic at Santa Clara University. The demeanor that he modeled in that work environment guides me in my continued professional life. He was always fair in his approach with everyone; his colleagues, the students he was leading, and the clients they were representing.

As I have moved through my career, I have sought counsel from Andy on tough decisions because I knew I could trust him to be honest and objective. I'd like to provide some context about my own career now. I am the Human Resources Officer for the Santa Clara Valley Open Space Authority. I follow Andy's model of bringing fairness and an emphasis on the human experience to this agency and the employees I serve. As a California Special District government agency, we work to conserve the natural environment of Santa Clara County, surrounding the urban interface of Silicon Valley. We

strive to balance the preservation of natural resources, wildlife, and watersheds with creating opportunities for the public to connect to the many benefits of nature through hiking, mountain biking, and equestrian activities.

Our family is very proud of Andy, his care for people, his respect for the law, and his fair approach to everything he does. As I was reviewing his application, I noticed that there isn't much explanation for why Andy hasn't been formally involved in the community as much since 2012. I'd like to take the opportunity to share a little about what I know that Andy has done during that time, which he is maybe too humble to share for himself.

In the last 9 years Andy has been very busy with family and business matters. He had to increase the level of care provided to his aging parents, both of whom had Parkinson's Disease. They also lived in California at the time, Andy had to regularly travel out of state to care for them, arrange for their medical care, and manage their financial affairs. In 2018 Andy's parents were able to relocate to Montana, which allowed Andy to participate in their day-to-day care. Ultimately Andy's father passed away in 2019, since then Andy has administered his father's estate and supported his mother in her activities, including helping with her financial affairs, coordinating her in home care, taking her to church and helping with her regular errands and shopping needs.

Andy has always been an incredibly supportive and involved father to his son. For four years this included supporting his son in a competitive traveling karate season for 6-months of the year.
