Dear Governor Gianforte:

Please accept this as my letter of support for Kathryn McEnery's appointment to the position of district court judge for the Montana Twentieth Judicial District for Sanders and Lake Counties. Kathy is ideally suited to assume this role for a variety of reasons.

First, district court judges encounter and must have the ability to decide a wide range of complex legal issues. Kathy has a broad range of practical experience in handling both complex civil and criminal cases of the type that a district judge must address on a daily basis. Kathy's intellect and experience in both private law practice and as a county attorney have prepared her to take on the position of district court judge without having to learn entirely new areas of law.

Second, as the Powell County Attorney, Kathy works hard to ensure that her cases are well-prepared and ready to take to trial in a timely manner. She will bring that organization to the bench, which will translate into prompt and fair adjudication of the cases that come before her. From my 26-year career litigating civil cases, one of the biggest problems I've encountered is the lengthy period of time it often takes to get a case from start to finish, with civil cases often taking at least one to two years to resolve. Having a district court judge who moves cases to resolution either by trial or motion practice is critical to ensure the smooth functioning of our system of justice. Kathy understands and will fulfill that duty in a faithful manner.

Next, a district court judge must be prepared to make hard, yet fair decisions based upon the law as established by the Legislature and binding case law precedent. Kathy knows and respects the limits of judicial authority, and will decide the cases that come before her in an impartial manner that will instill confidence in the public that its cases are being fairly decided.

Finally, Kathy has the calm but confident demeanor required of a district court judge (no one likes to appear before judges who are short-tempered or apparently apathetic towards their case). I have no doubt that Kathy will treat all parties that appear in her court with dignity and respect.

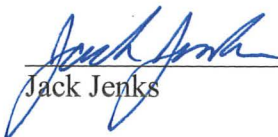
