I'm writing to recommend Thomas Pardy to replace the Hon. Michael G. Moses on the bench in the 13th Judicial District, Yellowstone County.

I have known Tom since approximately 1998. I became acquainted with Tom when he was a civil attorney working in a private Billings law firm.

I never had any difficulties working with Tom. Tom was always extremely professional and knowledgeable. Tom never took anything personal. Actually, it was a pleasure working and speaking with Tom. This is not always the norm in Billings.

Tom took time off for active military service. When Tom returned to practice law, we were reacquainted.

Tom accepted a position as a Billings City Attorney.

I have never heard another attorney complain about Tom, which is normally unusual in Billings.

I write this email in support of Tom's appointment for a position on the District Court. I believe Tom understands the workings of the Court and the work of the attorneys that regularly appear before the District Court.

Simply, many successful attorneys want to complete their legal career as a jurist, without any experience in the courtroom or representing actual litigants. I believe the majority of attorneys actually have no real day-to-day understanding of the judicial system, the incredible workload and stress upon the court and, understanding of the practice of attorneys that go to court regularly. I have found that big firm attorneys are rarely in court. Most large firm cases are settled at mediation prior to litigation.

The bulk of a District Court Judge's work in Billings is family law and criminal law. Most attorneys do not have any significant experience in family law and/or criminal law. Tom has experience in both family law and criminal law, representing people in hearings and trials.

Many big firm attorneys consider themselves litigators, and when pressed on the

number of court appearances they have made they normally set forth they litigate in discovery. That is distinctly different than being a courtroom practitioner.

I believe it is very important District Court Judges understand the requirements placed upon attorneys that appear regularly in family law matters and criminal law matters.

I know Tom has the ability to handle complicated business cases and causation cases. Tom has been a civil attorney for the City of Billings. Therefore, Tom understands the Billings business community. Tom, while in private practice, handled personal injury matters, family law matters, criminal law matters, etc., in District Court, which are the bulk of the matters before the court.

I do not want to take away anything from any of the other qualified candidates. However, I believe Tom has the most extensive legal experience in understanding the job requirements of a District Court Judge and the attorneys regularly appearing before the Judges.

Please consider my recommendation of Tom Pardy to replace Judge Moses as a District Court Judge in the 13th Judicial District for Yellowstone County. I make this recommendation without reservation.

I am writing this letter in support of Thomas Pardy to replace the Honorable Michael Moses as a State District Judge for the Thirteenth Judicial District of Montana. I have been a Federal Defender with the Federal Defenders of Montana for twenty eight years after eight years of civil trial practice. I retired at the end of 2021.

I have known Thomas since 2004 after he had been selected to be a member of the Criminal Justice Act (CJA) Panel of defense attorneys for the United States District Court in Billings. At the time I was the Branch Chief for the Billings Federal Defender Office. CJA attorneys were selected and approved by the sitting United States District Court Judge for the Billings Division. It was a small and select group of attorneys—about six or seven most of the time. The purpose of the CJA Panel of attorneys was to represent federal criminal defendants in cases where the Billings Federal Defender Office could not represent a defendant due to a conflict of interest or other significant circumstance. The Billings Federal Defender Office helped monitor the CJA Panel in Billings and conducted periodic Certified Legal Education (CLE) sessions for the panel attorneys.

In my position I became familiar with the CJA Panel attorneys representing federal criminal defendants and certainly Thomas. Like the other CJA Panel attorneys Thomas was in private practice and had a civil case load in addition to his CJA criminal law practice. These CJA attorneys were versatile and busy. Thomas was on the panel for five years at which time he became employed as a staff attorney for Mountain West Bank in Helena. He came back to Billings in 2013 and was welcomed back on the panel until he joined the City Attorney's Office in 2015 as a Deputy in the Civil Division.

I came to know Thomas as a forthright, engaging person with enthusiasm for his representation of federal criminal defendants. Thomas always made himself available to take on conflict clients as needed. He handled his cases effectively and demonstrated a high degree of motivation and compassion for his clients. He was noted to have successfully defended a defendant utilizing, for her great benefit, a nationally renowned false confession expert and obtaining a hung jury verdict. Utilizing such an expert was not favored by the U.S. District Court in Billings prior to this case. Thomas, however, was able to convince the Court of the necessity of doing so and used him effectively

My experience with Thomas during these years was very positive. He was well regarded and had a reputation for being an honest, hardworking advocate for his criminal defendants. There were no issues with his CJA vouchers as he was quite sensitive to submitting very fair accounting of his work. I believe that during this same time period he also litigated a few civil claims in the United States District Court in Billings, although I was not familiar with them.

In my view Thomas represents several qualities necessary to be an effective State District Judge in Montana. First he is honest and has conducted his affairs with integrity. He is, therefore, trustworthy. A more valuable trait for a judicial officer there could not be.

Second, he has gained experience in a wide variety of legal areas. He is presently a Deputy City Attorney which has made him familiar with state substantive law and procedures concerning municipalities—specifically the city of Billings. He has had his own law firm and engaged in various areas of civil practice. He has practiced criminal law in federal court as a CJA Panel attorney. He has delved into federal bankruptcy law and state law governing issues in real estate and contacts during his tenure with Mountain West Bank of Helena. This varied practice background will aid him in addressing the eclectic issues which face a state district court judge.

Third, Thomas is personable, respectful, thoughtful, and has leadership abilities—all of which would be most helpful in successfully engaging the citizenry of Billings and surrounding counties in the serious affairs of lawsuits, Court, and reaching fair results as a state district trial judge.

Fourth, his career has spanned well over 20 years and he has gained not just knowledge and familiarity with many areas of the law but also both life and practice experience in and out of the courtroom. During his career he has served this country in the military with several overseas assignments. He is well suited to being in charge of a courtroom and a caseload.

I highly recommend Thomas Pardy for this position. He has earned it and deserves it. He will serve the Thirteenth Judicial District well.

We also got to know each other pretty well outside of the military and law.

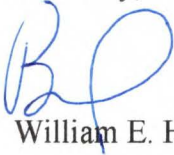
